GIS SERVICES AGREEMENT

This GIS Services Agreement (“**Agreement**”), effective the 10th day of September, 2025 (“**Effective Date**”), is entered into by and between IMEG Consultants Corp., a New York corporation (“**IMEG**”), and Roxborough Village Metropolitan District, a political subdivision of the State of Colorado (“**District**”). IMEG and the District are referred to collectively as the “**Parties**” and individually as a “**Party**.”

1. Scope of Services and Compensation. Subject to the terms and conditions of this Agreement, IMEG shall provide as-needed/on-call GIS support for the District based on its standard hourly rates for time and materials set forth in Attachment A (“**Services**”). IMEG will provide estimated costs for the Services requested before providing the Services. IMEG shall submit an invoice to the District by the 1st day of the month following any month in which Services were performed by IMEG or any subcontractor, consultant, or other individual or entity performing any portion of the Services (collectively, the “**IMEG Parties**”). IMEG’s invoices shall include a description of the Services, the date the Services were performed, the man hours worked, the position and rate of each employee or IMEG Parties that performed any Services, and the cost of equipment or materials used. The District shall pay the undisputed portion of an invoice within 30 calendar days after both satisfactory completion of the applicable Services and its receiving the associated invoice from IMEG. Interest (but no late fee or penalty) shall accrue at the rate of 8% per annum on any undisputed amount the District fails to pay by the date due until the undisputed amount is paid in full.

2. Ownership of Work Product. All documents, data, and information of whatsoever kind or nature, and whether in paper, electronic, or other media form or format, that IMEG generates, obtains, or maintains in performance of the Services, directly or through a third-party consultant or contractor (collectively, “**Work Product**”), shall be the District’s sole property and may not be used, sold, distributed, or disposed of in any manner without the District’s prior written approval. Upon termination or expiration of this Agreement, or at any other time upon the District’s request, IMEG shall deliver the Work Product to the District.

3. Standard of Care. IMEG represents all Services will be performed with competence and in accordance with the standard of care of IMEG’s profession prevailing in Colorado. IMEG shall be fully responsible for the professional quality, technical accuracy, and timely completion of the Services, including all work and reports that are a part thereof, whether such Services are performed directly by IMEG or one or more of the IMEG Parties. Without additional compensation and without limiting the District’s remedies, IMEG shall promptly remedy and correct any errors, omissions, or other deficiencies in the Services caused by IMEG or one or more of the IMEG Parties.

4. Independent Contractor. In performing the Services under this Agreement, IMEG shall be, for all purposes, an independent contractor and not a District director, employee, or agent. IMEG and the IMEG Parties shall in no way represent themselves to third parties as a District director, employee, or agent. Neither IMEG and its employees nor any of the IMEG Parties are entitled to unemployment or workers’ compensation insurance benefits as a result of performing any portion of the Services.

5. Insurance. IMEG shall not perform any Services until the following minimum insurance coverages have been obtained:

- a. Workers' Compensation Insurance in the amount required by Colorado law;
- b. Commercial General Liability Insurance in the amount of \$1,000,000 for each occurrence and \$1,000,000 general aggregate in combined single limit coverage for bodily injury and property damage.
- c. Professional liability insurance, including errors and omissions insurance, in the amount of \$1,000,000 per claim and \$1,000,000 aggregate.
- d. Automobile Liability Insurance to include owned, non-owned, and hired vehicles in the amount of \$1,000,000 per occurrence and \$1,000,000 general aggregate and combined single limit coverage for bodily injury and property damage.

The required Commercial General Liability and Automobile Liability policies shall: (i) include "Roxborough Village Metropolitan District" as an additional insured for coverage only, with no premium payment obligation; and (ii) state that the District's insurance is non-contributory. IMEG shall provide Certificates of Insurance (and renewals thereof) and/or endorsements identifying this Agreement and demonstrating that the required coverages have been obtained.

6. Indemnification. To the extent authorized by law, IMEG shall indemnify and defend the District and its directors, officers, and agents from and against liability, loss, damage, demand, action, cause of action or expense, including but not limited to damage for personal injury, property damage, or financial loss (including court costs and reasonable attorneys' fees) that are caused by the Services performed by IMEG or one or more of the IMEG Parties, or IMEG's breach of this Agreement. The District shall have the right to select its legal counsel notwithstanding IMEG's obligation to pay the attorneys' fees, costs, and expenses incurred by such legal counsel.

7. Term and Termination. This Agreement shall commence effective September 10, 2025, and expire on December 31, 2025, and thereafter shall automatically renew for successive one-year terms, unless terminated pursuant to this Agreement. Either Party may terminate this Agreement upon 60 calendar days prior written notice to the other Party. In addition, either Party may terminate this Agreement if the other Party breaches this Agreement and fails to cure such breach within 20 calendar days from the date the non-breaching Party provides written notice of the breach. Subject to the District's right of nonappropriation, IMEG shall be paid for all Services satisfactorily performed through the termination date.

8. Nonappropriation. Nothing in this Agreement shall be construed as creating a direct or indirect multiple fiscal year financial obligation of the District. The District's indirect and direct financial obligations are subject to the District's Board of Directors appropriating funds to pay such financial obligations for an upcoming year. If the Board fails to appropriate funds to pay the District's direct and indirect financial obligations for an upcoming year, this Agreement shall terminate on December 31 of the year in which the nonappropriation occurred without any liability to the District whatsoever beyond any remaining funds that the Board appropriated to pay the District's direct and indirect financial obligations in the year in which the nonappropriation occurred.

9. Non-Exclusive Agreement. IMEG acknowledges and agrees this is not an exclusive agreement, and the District may retain other persons or entities to perform similar services in the District's sole discretion.

10. Governmental Immunity. Nothing in this Agreement shall be construed as a limitation on or waiver of the rights, privileges, immunities, defenses, limitations, and benefits provided under federal and state law, including but not limited to the Colorado Governmental Immunity Act, C.R.S. 24-10-101, *et. seq.*

11. Notice. Notices shall be in writing and given by hand delivery or certified/registered mail, return receipt requested, to the address on the signature page, or at another address a Party previously furnished in writing to the other Party pursuant to this Section. A notice sent by certified/registered mail is deemed given when received or three business days after deposit in the mail, whichever occurs first.

12. Additional Terms. Colorado law governs this Agreement. This Agreement is the entire agreement between the Parties and there are no oral or collateral agreements or understandings. Jurisdiction and venue shall lie exclusively in the District Court for Douglas County. This Agreement may only be amended by a document signed by the Parties. If any provision is held invalid or unenforceable, all other provisions shall continue in full force and effect. Waiver of a breach of this Agreement shall not operate or be construed as a waiver of any subsequent breach of this Agreement. This Agreement is not assignable. This Agreement is not intended to, and shall not, confer rights on any person or entity not named as a party to this Agreement. In any civil action or proceeding arising from or relating to this Agreement or the Services, the prevailing Party shall be awarded its reasonable attorney's fees, costs, and expenses, including the reasonable attorneys' fees, costs, and expenses incurred in any appellate action and in collecting or executing upon any judgment, order, or award. This Agreement may be executed in counterparts and by facsimile or electronic pdf, each of which shall be deemed an original and all of which shall constitute one valid and binding instrument.

Here is the information I was able to gather on cellular, solar-powered cameras:

- Every camera will require its own cellular SIM card, which represents a monthly, recurring cost. If these cards are "bundled" in a plan, this can significantly reduce costs. The ballpark cost for those SIM cards would be between \$15-\$30/month per camera.

I prioritized options that had no recurring cloud, administrative or subscription payments, so the SIM cards would represent the only ongoing cost. The models I found are as follows:

The ranked choice method would not be the instant runoff or single transferable vote methods proposed in Colorado or utilized in other states. It would use the Schulze single transferable vote method to ensure voters are proportionally reflected in the outcome with a minimum ability to game the system.

Issues with the current system:

- Because metro districts do not have primaries, ballots can have a significant number of candidates where voters feel like they need to guess how others will vote to make sure their vote counts.
- Voters can feel disenfranchised when candidates from larger neighborhoods are disproportionately elected to the board.

Benefits of ranked choice:

- There is no need to strategize how you vote or synchronize with other voters.
- The Schulze single transferable vote method ensures the most liked candidates are elected.
- The board will more often proportionally represent the demographics of the district.

Downsides of ranked choice:

- The current voting method where the candidates with the most votes win the election is very simple to calculate whereas the Schulze single transferable vote method requires a computer to tally the votes.
- Initially, some voters may find ranked choice ballots confusing.
